## 6th Amendment vs. Massachusetts Bar Advocate Strike

According to the United States Constitution, it is our 6th amendment right to have an attorney appointed to us, even if we cannot afford one. This ensures that defendants can be properly represented and treated fairly. That begs the question: what if there are no attorneys to appoint?

In Massachusetts, bar advocates (private attorneys paid by the state appointed to defend defendants) have gone on strike due to cuts in their pay. This has left many defendants with no representation. After 45 days without representation, defendants are required to be let go. Consequently, many have been set free. <sup>1</sup>

According to the Massachusetts Supreme Judicial Court, the bar advocate's pay rate is unconstitutionally low. In fact, Massachusetts bar advocates are the third-lowest-paid attorneys in the entire country. <sup>2</sup>

The legislature has offered to give a pay raise of an extra twenty (20) dollars per hour, although thirty-five (35) was requested. The legislature also included in the agreement that if bar advocates refuse to work because of their pay in the future, it would violate antitrust laws. Lawmakers think this is enough, but the majority of bar advocates disagree, stating that they will not go back to work unless they obtain the pay that they requested.<sup>3</sup>

If the bar advocates continue to strike, many more defendants will be set free, and their charges will be dropped. In other words, their absence is becoming disastrous. Defending people is not an easy job, and ultimately, these attorneys deserve better.
